Supervisor Simpson called the regular meeting to order at 7:00 PM.

Local Board of Health...

Mark Schachner

A Motion was made by Councilperson Olson, seconded by Councilperson Smith, to go into session as the Local Board of Health. The Board moved into session as Local Board of Health at 7:00 PM.

Re-convene Public Hearing - Septic Variance request at 206 East Shore Dr / Derr / tax map #36.3-3-15:

-Zack Monroe, Winchip Engineering, asked the Board if there were any questions on the proposed system.

-Councilperson Olson asked if the adjoining landowners received a copy of the revised proposal with their public hearing notice. ZA Steen said the Town Clerk did include copies of the revised proposal with the notices. Councilperson Olson asked Mr. Monroe if the gray water system would be removed upon installation of the new system; Mr. Monroe confirmed that it would be removed.

There being no further comments the public hearing was closed at 7:06 PM.

Councilperson Olson asked Mr. Monroe if Winchip Engineering will certify the system once it is installed. Mr. Monroe said they will if the customer chooses them to do the certification. Councilperson Olson said he feels the proposed system is substantially better than what is there.

Supervisor Simpson said there is no other option for placement of the system; the proposal provides for the least variance necessary and is the best location to maximize the setbacks.

RESOLUTION #129-2019

Councilperson Olson and Councilperson Higgins introduced Res. No. 129 and moved its adoption:

RESOLUTION TO GRANT VARIANCE FOR A REPLACEMENT SEPTIC SYSTEM AT 206 EAST SHORE DRIVE

RESOLVED, that the Horicon Town Board acting as Local Board of Health, based on the receipt of a set of stamped plans from Winchip Engineering (project #19-065), and the \$100.00 variance fee, does hereby grant a variance for an alternative septic system at 206 East Shore Drive, Adirondack (Tax Map #36.3-3-15) because the strict application of the minimum setback requirements, or the minimum lot size requirement, would result in a specified practical difficulty to the applicant. Further, the alternative proposed would not be materially detrimental to the purpose of this regulation, or to the property or natural resources in the area in or near the site of the proposed individual sewage disposal system, or otherwise conflict with the description, purpose, or the objectives of any plan or policy of the Town, and that the alternative proposed is the minimum variance which would alleviate the specified practical difficulty as found by the Board to affect the applicant.

Septic Variance request for 73 Burnt Pond Estates Rd / Brunner / tax map #105.-2-18:

Zack Monroe, Winchip Engineering, explained the proposal to install a holding tank system to deal with wastewater coming out of the residence. Mr. Monroe explained the home has a bed, but not a formal bedroom, a sink, an incinerating toilet, and a shower, but does not have hot water or laundry. He said they are proposing

a holding tank because the bedrock on the property would make it extremely difficult, if not impossible, to find a spot to install a septic system. He said the proposed system will require a variance for the use of a holding tank for new construction, and a variance for a decrease in design flow from 150 gallons per day to 70 gallons per day.

RESOLUTION #130-2019

Councilperson Higgins and Councilperson Olson introduced Res. No. 130 and moved its adoption:

RESOLUTION TO SET PUBLIC HEARING

RESOLVED, that the Town Board of the Town of Horicon, acting in its capacity as the Local Board of Health, considers the application made by Winchip Engineering for a septic variance at 73 Burnt Pond Estates Rd in Brant Lake complete, and does hereby set a Public Hearing for Thursday, December 19, 2019 at 7:00 PM at the Horicon Community Center.

Councilperson Olson asked if the size of the proposed holding tank will be sufficient; Mr. Monroe said it will. Councilman Higgins asked if it will have an alarm system, and Mr. Monroe said it will. Councilperson Olson asked if it would be more cost effective to have a bigger holding tank rather than having a smaller tank pumped more often. Mr. Monroe said this was considered, however, the size of the proposed tank does meet code, and the other problem is getting a larger tank in with all of the bedrock.

Supervisor Simpson asked ZA Steen if any future additions to the structure would require Town Board review in regard to the septic. ZA Steen said the use of the property was not represented accurately in the past and this is the concern going forward; the future owners may add a regular toilet, hot water, and laundry without the town knowing. ZA Steen noted they have misrepresented in the past so they may do so again. Mr. Monroe addressed ZA Steen's concerns, noting DOH design flow standards are 110 gallons per day per person for 5 days so a 550-gallon holding tank would be required. He said the proposed 1,000-gallon tank is sufficient for the amount of water that would be used even if a regular toilet and laundry were installed.

Motion was made by Councilperson Olson, seconded by Councilperson Smith, to move back into regular session. The Board moved back into regular session at 7:22PM.

<u>Town Septic / St. Theresa's:</u> Supervisor Simpson said notice was sent to Mr. Kruz, owner of St. Theresa's church, stating his connection to the Town's septic will be disconnected on December 2nd. He said he has not heard back from Mr. Kruz so he will send another notice prior to the disconnect on December 2nd.

<u>1881 Union Church:</u> Supervisor Simpson said the basement is dried out now. He explained the ground fault circuit tripped during the recent heavy rainfall and that is what caused the basement to flood. Councilperson Hill said the sump pump in the basement worked 24/7 for quite a few days in the basement. He said this water issue will need to be addressed in the spring. Supervisor Simpson said the contractor needs to fix one window for the County and then the project will be complete.

New Business...

Brant Lake Flooding: Supervisor Simpson said the recent storm raised the lake level considerably and concerns have been expressed. He spoke with Don Rhodes, of Laberge, who told him the Town can do a study, which would cost approximately \$10,000 - \$15,000, to see what could be done. Supervisor Simpson said Laberge explained it is not a matter of just releasing more water as that would affect the lower dam as well as properties downstream. Supervisor Simpson said if changes are made to the dam it could change the dam classification back to a high hazard dam, require costly changes to the dam and the bridge, and make obtaining insurance coverage very difficult. He stressed there are bigger issues at stake and many things to take into consideration. Supervisor Simpson will ask Don Rhodes, from Laberge, to attend an upcoming meeting to discuss the situation and answer questions. The Board agreed this would be the best approach.

Privilege of the Floor...

HORICON TOWN BOARD REGULAR MEETING

NOVBER 21, 2019 7:00 PM

-Peter Palmer said, in his opinion, the issue is not so much the flooding on the lake, it is the fact that the water just does not go down fast enough. He said the problem was created when the cement support piers were poured by the wing walls which narrowed the dam a foot, and this makes a big difference. Mr. Palmer said this has created a situation where the water takes weeks to drain down to a normal level. Supervisor Simpson explained that the 6" concrete piers were put in to support and protect the dam because the wing walls, which are owned by the County, were hollow. He added that based on the engineer's survey the additional 6" of concrete on each side of the wing walls only impacts the overall level of the lake by one inch. Supervisor Simpson noted that none of that was done without the engineer reviewing the impact on the lake. Mr. Palmer said something has to be done about this; there has to be other ways to let water out of the lake. Supervisor Simpson said there are other factors besides the width that are affecting the dam such as the velocity and the depth of the water. He noted it will be best to hear from the engineers.
