Supervisor Simpson called the meeting to order at 8:00 am.

Councilperson Smith made a motion, seconded by Councilperson Hill, to go into Executive Session to discuss matters leading to the appointment or employment of a particular person. Councilperson Olson stated he would not participate in the Executive Session due to a conflict of interest. The Board moved to Executive Session at 8:01 AM.

The Board returned from Executive Session at 8:08 AM and Councilperson Smith made a motion, seconded by Councilperson Hill, to return to Regular Session, Ayes: 3 (Smith, Hill, Simpson) Abstain: 1 (Olson) Absent: 1 (Higgins). Supervisor Simpson stated no action was taken.
