# Committee Reports...

-Councilperson Palmer said he spoke to HS Darian Granger about putting together a storm water runoff plan so the Town Board knows how these issues are handled. Councilperson Olson commented that Pat Farrell recently gave the Board an extensive plan, but the town cannot afford to implement the type of program he proposed. Supervisor Simpson said that WC Soil and Water has the expertise on this, and FEMA is also updating their procedures for handling storm water runoff.

-Councilperson Olson noted one of the ZBA alternates needs to be moved up to fill the ZBA seat vacated by Scott Olson, and the Board also needs to advertise for a PB alternate and a ZBA alternate.

#### New Business...

NWEMS payment schedule: Issachar Modert, NWEMS Operations Manager, said the Squad is requesting the Town pay the yearly contract in two installments rather than in four installments. He explained the reason is that the beginning of the year is generally a slow time, and this will help them avoid being spread to thin financially. Mr. Modert also noted that Chester pays in two installments. Supervisor Simpson expressed concern noting the Squad could get into financial trouble this way as it would be more difficult to manage cash flow. He suggested a better option would be to pay the Squad in monthly installments. Mr. Modert said that was fine, but it would create more paperwork for everyone; Supervisor Simpson did not feel that would be an issue. Councilperson Olson said he was concerned as to whether the Town would have the funds available to make the larger payment in February; Supervisor Simpson said the funds would be available. Supervisor Simpson also noted the Town loses security in services when pre-paying so far in advance. He told Mr. Modert that if the Squad is asking for this because there are issues then the Board needs to know what is going on. Mr. Modert said there are no issues. Councilperson Palmer said he feels the Board should amend the contract if it works for the Squad and review it in a year. Councilperson Hill agreed with Councilperson Palmer. Supervisor Simpson said the Squad will need to provide call run reports and financial reports on a monthly basis going forward. He also said he would like Councilpersons Smith and Olson to meet with the Squad on a monthly basis.

## **RESOLUTION #54-2020**

Councilperson Palmer and Councilperson Hill introduced Res. No. 54 and moved its adoption:

## **RESOLUTION TO AMEND 2020 CONTRACT WITH NORTH WARREN EMS**

WHEREAS, the North Warren EMS has requested that the Town of Horicon pay them the contract amount of \$120,250.00 in two equal installments of \$60,125.00 per year rather than in four installments as has been done in the past, now, therefore be it

RESOLVED, that the Town Board of the Town of Horicon does hereby amend the 2020 contract with the North Warren EMS to make two equal payments of \$60,125.00, with the first payment to be made the Friday following the third Thursday in February and the second payment to be made the Friday following the third Thursday in June. The balance of the first payment will be made upon execution of this amended contract by both the Town of Horicon and the North Warren Emergency Squad, and be it further

RESOLVED, that the Town Board does hereby further amend the 2020 contract to require the North Warren EMS to provide monthly financial reports and monthly reports of calls effective immediately.
