Committee Reports...

-Councilperson Sylvia Smith recognized Don and Bonnie Rosbozom who have been volunteering their time to take care of the flowers around Town. She said the Rosbozom's have also offered to help with planting in the spring. She noted the final report for the CFGMR grant awarded to the Town for the Adirondack playground project will need to be completed by June of next year so a strategy needs to be developed for the project; Paradox Consulting had a training session for the Community Center staff on July 23rd; the new sign/banner holder has been in since July and there have been numerous positive comments on the positioning of it and the visibility; she reminded everyone that, as previously discussed and agreed upon by the Board, Kevin and Rob (Beautification crew) will handle hanging all banners and taking them down; the Library has asked for \$5,000 for 2019 and she has asked Joan Johnson for detail as to what the money is needed for; the Adirondack Shindig was a success; the repair work needs to be done on the Horicon Museum and the Historical Society will have three estimates for that; lastly, Councilperson Smith said the Historical Society will be doing a pre-holiday newsletter, which they received a CFGMR grant of \$970 for, and she asked that anyone with stories about the Town please submit them for the newsletter.

-Councilperson Bob Olson said he spoke to Town Counsel Mark Schachner about preparing a draft amendment to the Zoning Ordinance regarding travel trailers in the R1 zone that could be taken to public hearing. He said it is important to address travel trailers in the R1 zone promptly, and then re-visit those in the backcountry later. Motion made by Councilperson Olson to have Counsel prepare a draft amendment to the Zoning Ordinance for public hearing, no second. Councilperson Higgins said he feels more information is needed prior to making any changes, as he is not in favor of making any changes and does not see the problem. Supervisor Simpson noted ZA Jim Steen has several other items that need to be addressed so it would be more efficient to address them all in one proposed amendment rather than one at a time. Councilperson Olson said he is in favor of drafting a proposed change and taking this to public hearing. Supervisor Simpson suggested lots could possibly be defined as a campground on which no more than one travel trailer per lot is allowed, however Town Counsel noted campgrounds usually relate to the exchange of money. Councilperson Higgins said he will meet with ZA Steen to get more information on this; Councilperson Sylvia Smith agreed that more discussion is necessary prior to taking action.

-Robert French, Horicon NWEMS Representative, reported to the Board the NW Emergency Squad made 96 calls. He said they have recently reached an agreement with Schroon Lake EMS to bill for Schroon Lake calls.

RESOLUTION TO AMEND THE HORICON VOLUNTEER FIRE DEPARTMENT, INC LOSAP TO SELF-INSURE

WHEREAS, eligible voting residents of the Town of Horicon approved a referendum to establish a Length of Service Award Program for active volunteer firefighter members of the Horicon Fire Department, Inc., effective March 1, 1999, in accordance with Article 11-A of the New York State General Municipal Law (hereinafter the "Law");

WHEREAS, the Town Board of the Town of Horicon (hereinafter the "Board") is the Program Sponsor and

Program Administrator of the Horicon Fire Department, Inc. Service Award Program (hereinafter the "Program");

WHEREAS, under the current Program provisions, if a Pre-Entitlement Age Participant is an active volunteer firefighter of the Horicon Fire Department, Inc. at the time of his or her death, the member's designated beneficiary or Estate if no beneficiary is designated is entitled to an additional lump-sum death benefit in the amount of \$10,000 from the Program;

WHEREAS, the Town currently has a group-term life insurance policy in effect to provide funding in the event that an additional death benefit is payable from the Program;

WHEREAS, the current annual premium to renew the life insurance policy for all Active Members of the Horicon Fire Department, Inc. is \$484;

WHEREAS, such additional death benefit can be funded annually by means of the actuarially-determined contribution made by the Town of Horicon to the Trust Fund (hereinafter, "self-insure"), whereby the benefit would be made payable from the Trust Fund similar to all other entitlement and death benefits provided by the Program, and is consistent with the current provisions of the Program; and

WHEREAS, the estimated annual cost of self-insuring this additional benefit by means of the Town's annual contribution to the Trust Fund is approximately \$180; now, therefore, be it

RESOLVED, that the Horicon Town Board agrees to terminate the group-term life insurance policy in effect and incorporate the cost of funding the additional \$10,000 Pre-Entitlement Age Death Benefit in the actuarially-determined contribution calculated by the actuary. The 2019 calendar year actuarially-determined contribution for the Horicon Fire Department Service Award Program has been calculated to be \$16,459, which includes reimbursement for all administrative fees paid from the Trust Fund during the 2017 calendar year totaling \$5,300. As a result of this resolution, the annual cost of the Program is estimated to decrease by \$900 for a total estimated cost of \$15,550, which includes an estimated \$4,300 for all administrative fees to be paid from the Trust Fund during the 2017 calendar year.

All other provisions of the Program shall not change as a result of this resolution and the Program shall continue to be administered by the Governing Board of the Town of Horicon in accordance with Article 11-A of the New York State General Municipal Law.
