1) Public Hearing for septic variance request at 1593 Palisades Rd / tax map #39.17-1-35:

Supervisor Geraci opened the public hearing for the septic variance request at 1593 Palisades Road in Brant Lake at 6:00 pm.

-Tom Hutchins, Hutchins Engineering, briefly reviewed the proposal again which is to install a conventional septic tank with an Eljen GSF sand filter absorption bed. Mr. Hutchins noted that only the owner's well is impacted, and because of the reduced well setback an ultraviolet disinfection system will be installed on the water supply inside the new residence.

He said they are requesting the following variances:

- 1) Proposed absorption bed to owner's well where 100' is required, 86' is proposed, which is a variance of 14'.
- 2) Proposed absorption bed to property line where 10' is required, 5' is proposed, which is a variance of 5'.

-Councilman Olson asked Mr. Hutchins if the proposed plan uses the location of the structure that was approved by the ZBA; Mr. Hutchins confirmed that the structure location on the proposed plan is based on what was submitted and approved by the ZBA. Councilman Olson said he feels the variances are minimal and this is the best possible solution based on the small size of the lot.

-Councilman Hill agreed saying he feels this is the best-case scenario.

There being no further comments Supervisor Geraci took a motion from Councilman Olson, seconded by Councilman Hill, to close the public hearing. The public hearing was closed at 6:05 pm.

Old Business:

Update on de-icing systems: Supervisor Geraci said he has approached the County on the possibility of partnering on the issue of de-icing systems and most of the Board of Supervisors were in agreement with the idea. He said the partnership has been formed and the offices of Warren County Public Affairs and Warren County Planning will take the lead on this. These offices will handle the design and content of the informational materials as well as the distribution. Supervisor Geraci said they will also apply to the Occupancy Tax Committee to fund this project. He said the intent is to promote best practices in terms of safety on the ice. He is hopeful to have a draft at next month's meeting.

Joe Brand debt to Town: Supervisor Geraci said the Town had contracted with Mr. Brand for bottle recycling at the Landfill. He said, unfortunately, on two separate occasions Mr. Brand picked up bottles but the town was not paid. He said Mr. Brand paid the Town \$160.00 but he still owes the Town a balance of \$527.18. Supervisor Geraci said he has had numerous discussions with Mr. Brand about repaying the money owed to the Town but there has been no movement on this. Councilman Palmer said it should be referred to the police, but Supervisor Geraci said there are other options to recoup the money. He said the amount of money is small but it is the principal of the matter. Supervisor Geraci asked the Board if they would like to move forward with this. The Board agreed to have Supervisor Geraci follow up on this.

Health care broker discussion: Supervisor Geraci said that with the unbelievable increase in health care costs he believes there is a need to get the best benefits possible, and at the best cost, for the retirees and employees. He said the Town is at a point right now where they can change to a new broker. He said that in addition to looking at plans, you also have to look at the customer service provided to the employees. He noted that when employees have questions they need to get answers, and he has found a company that can do this. He recommends Hometown Solutions, a local firm in Glens Falls, independently owned by Debbie Bell. She has agreed to meet with all of the employees soon so people understand what is going on with their insurance. Supervisor Geraci asked the Board how they would like to move forward.

New Business:

Fred Holman / Winterization program outreach: Mr. Holman reviewed three programs offered through NYS that would be helpful to residents. The first is the HeatSmart program, through NYSERDA, which is aimed at winterizing low-income residential properties to improve energy efficiency. The second program, Clean Energy Communities, is a program for towns. There are activities that can be done to address issues within the town; the town also gets credit for things that have already been done since 2016. Once the town earns so many credits for these activities they are able to get grant money for other projects related to energy conservation. The third program, Local Climate Action – Energy Smart Communities, is where towns commit to energy conservation, safety, and renewable energy. This program also allows towns to earn credits in order to obtain grant money. Mr. Holman said he has spoken to representatives at the State and the County and both are willing to come and discuss these plans with the Town.

Privilege of the Floor...

- -Rich Nawrot asked if he understood correctly that the public hearing for the tax cap was cancelled because the budget did not go over the tax cap, and part of that was the funding of the Ambulance District? Supervisor Geraci explained that the tax cap applies to the entire budget of which the Ambulance District is a part of. He said the Ambulance District is now broken out into its own separate line in the budget. Mr. Nawrot said he thought the tax cap was going to be exceeded because of the Ambulance District. Mr. Geraci said that was not the case. He clarified that the Board set the public hearing in case the budget as a whole exceeded the tax cap.
- -Rich Nawrot asked if there should be a ZBA member on the committee that will be reviewing possible amendments to the Zoning Ordinance. Interim ZA Christine Hayes said absolutely not; the ZBA does not have any authority for any of the laws, the Town Board has the authority to make the laws of the Zoning Ordinance. She noted the ZBA interprets the Ordinance when there is an appeal to a decision made in the Zoning office, but they do not make the rules.
