#### Four-year Town Board appointment:

Supervisor Geraci explained that Tom Donahue, Jr. had resigned from the Town Board, but it was too late to remove his name from the ballot. Tom won the election and has resigned again which leaves the four-year term open. Mr. Geraci said the Board has several options; they can do nothing and leave the seat open, they can appoint one of the two write-in candidates, or they can appoint anyone they want. He said they could wait until the petitions come out in February and see how many candidates there are; if there is only one and that person wins the primary then the Board could appoint after the primary.

Supervisor Geraci said the petitions will be available February 27<sup>th</sup> and they must be in April 4<sup>th</sup>. He noted this is on the Warren County Board of Elections website.

Councilperson Palmer made a motion not to appoint until the petitions are filed. Councilperson Olson seconded the motion.

Councilperson Smith said she is not comfortable not having a full Board as it is not fair to the community. She noted all community comments need to come back to the Town Board and with only four members you are missing a whole voice to bring back what the community wants. She said whoever the Board appoints will have to run in November anyway because the appointment is only for a year. Mrs. Smith added the Board has run too many times with only four Board members, it does not work, and it is not fair to the community. She said she is not in favor of leaving the seat open and votes against the motion.

Councilperson Carlozzi said the townspeople did come out and vote, and although the votes were very close, Tom Donahue did resign but there was a candidate with the second highest number of votes. She said feels the

townspeople voted and, therefore, the Board should appoint that person for a one-year term in fairness to the Town. She noted again that it is only a year since the candidates will need to run again in November.

Councilperson Smith said there are two young candidates that are interested in serving and the Board should take advantage of that by appointing to make it a full Board.

Councilperson Palmer said both candidates got almost the same number of votes and he is not going to be the judge of that. Councilperson Smith pointed out it is close sometimes, noting that Craig Leggett had won his initial election by only two votes. Councilperson Palmer said he does not care, the difference is the public voted for Craig. He said John and Teri were two last minute candidates and he is going to let the public vote. Barb French noted the people did vote. Councilperson Palmer said he is not going to make a decision; he is going to wait and see who runs, end of subject.

Councilperson Smith asked what happens if four people file petitions, that would mean the Town would run half a year with only a four-member Board. She said she is in favor of appointing in order to have a full Board, and then let the candidates run in November.

Supervisor Geraci said the Town of Horicon is a town of the second class which means the Town can run with only a three-member Board, however, the decision was made years ago to have a five-member Board. He said the people did vote and they voted for Pete Palmer and Tom Donahue; the two write-in candidates were within four votes of each other. Mr. Geraci said the Board of Elections did not dismiss any votes and came up with their tally.

Teri Schuerlein said she called the Board of Elections for clarification on what the Town Board can do. She said they told her the Board can appoint an individual and that individual will have to run in November. She said the townspeople put her and John Francisco on the ballot, and the voters, over 250 of them, took the time to write in their vote which means those voters want representation on the Town Board. She said to wait a year is not taking the voters of the Town into consideration.

Bernie Bolton said he agrees; the Town needs a full Board for the community. He noted the people can run in November but right now there are two good candidates and asked what the disadvantages are of a full Board. Supervisor Geraci said this is not a debate.

Gary McMeekin said he agrees with Councilperson Smith and Bernie. He said there are two candidates ready to serve, and it is the Town Board's duty to appoint in order to have a full Board.

Matt Wood said it was a legal election, two people stepped up to run, and there was a winner. He noted people took the time to vote and the Town Board should take that into consideration. He said if the Board waits for the petitions to be filed and then waits to see who wins the primary that means the Town will run with a four-person Board for a minimum of six months. He said running with a four-member Board does not work.

Supervisor Geraci said they ran with a four-member Board after Frank Hill died.

Barb French said the Board is constantly saying they need more people to come to the Board meetings; they need people to step up. She said this gives the wrong idea because people wonder why they should bother to vote if it is not going to mean anything. She asked why the Board would not appoint, noting her father lost an election by one vote. Supervisor Geraci asked if he was on the ballot, Barb said they both were, Supervisor Geraci said that is the point. Barb said people wrote John and Teri's names on the ballot.

John Francisco said he intends to run in November, and he is fine with the Board appointing someone now.

Councilperson Smith addressed the Board noting it is not easy to vote the way you know you should, but you must because we are here to represent the community. She added that both candidates are supportive of one another.

Supervisor Geraci said there is a motion on the floor made by Councilperson Palmer, seconded by Councilperson Olson, not to appoint; he asked the Board if they want to appoint rather than leave it open. Vote is as follows: Hold the position vacant: Palmer – yes, Olson-no, Carlozzi – no, Smith – no, Geraci – yes. Supervisor Geraci noted the motion failed.

Supervisor Geraci told the Board to interview who they would like and be ready to bring forth a candidate for appointment at the January 4<sup>th</sup> organizational meeting.

Additional comments:

Supervisor Geraci pointed out the Transfer Station is now running at a surplus, not a deficit, and congratulated Barb for how she operates the Transfer Station.

Supervisor Geraci asked Assessor Christine Hayes to explain the proposed tax exemption for firefighters and first responders. Assessor Hayes explained the exemption provides for 10% off the individual's tax bill. However, she said with the Town tax rates being so low the taxpayer would have to have a home assessed for at least \$500,000 in order to get the exemption; there are not too many in Town that would qualify. Supervisor Geraci added it sounds like a very good plan but, in reality, that is about all it does.

Supervisor Geraci noted Warren county is starting their senior transportation program back up and service for Horicon will be on the second and fourth Tuesdays of each month.

He said he is part of a committee that is doing a feasibility study for a morgue for Warren County; it is a very complex, very expensive project, but it is needed.

#### Additional comments from Board members:

-Councilperson Olson said he is concerned about the loss of personnel noting the long-standing need for members on both the Planning Board and the Zoning Board of Appeals. He said the Town needs to do something different and find out why people do not want to serve.

-Councilperson Palmer said he finally has more than two keys for the dam. He said the new tractor is in at the Highway Garage if anyone wants to see it. He said when the Board starts discussing the church and garage, they need to think about the future because the food pantry is at its max and is going to need to be addressed.

-Councilwoman Carlozzi said she is working on the Town's social media. She suggested putting job openings on social media because that is where the younger generation looks. She said Warren County is working on their 2040 project and encouraged people to take interest in what is going on. Supervisor Geraci said there is a quick response code that will take people to the link for the County's Comprehensive Plan.

-Councilwoman Smith said she has been doing follow-up for the stage lighting for Food Truck Fridays as well as with Brian Johnson on the Heintzelman Library window project. She told Brian to go ahead and order all the windows for the Heintzelman and to be ready to do the columns and the entryway; this work will be covered by the grant they received.
