Supervisor Geraci opened the regular meeting at 6:00pm.

Councilmember Bob Olson announced that due to health reasons this will be his last Town Board meeting. He said he wants everyone to know how proud he is to have served, and it is with great sadness that he must step down.

Supervisor Geraci thanked Councilmember Olson, on behalf of the current Town Board, for his service to the Town over the past twenty-six plus years. He told Councilmember Olson the Town owes him a large debt of gratitude and he should be very proud of his accomplishments. Supervisor Geraci expressed to Councilmember Olson that he has made a big difference to the Town over the past twenty-six years; adding that a lot of what the Town is proud of today is in part because of the work Councilmember Olson has done.

Supervisor Geraci then asked for a motion to convene the Local Board of Health. Motion was made by Councilmember Carlozzi, seconded by Councilmember Olson, to go into session as the Local Board of Health. The Board moved into session as Local Board of Health at 6:05 PM.

#### Local Board of Health...

<u>Public Hearing - septic variance request for Grenier / 7296 State Rt 8 – trailer B-1 / tax map #72.6-1-2:</u> Supervisor Geraci opened the public hearing at 6:05 pm.

Liam Harrison, KSPE LLC, briefly explained the proposal to install a replacement wastewater disposal system. He said they recently learned the property is classified as a "campground," therefore this project must also be reviewed by the Department of Health. Mr. Harrison said the NYS DOH representative said they hoped to have approval on this within the next couple of weeks. He asked the Board for conditional approval of the variance pending review and approval by the NYS Department of Health.

There being no further comments Supervisor Geraci took a motion from Councilmember Olson, seconded by Councilmember Francisco, to close the public hearing. The public hearing was closed at 6:10 pm.

RESOLVED, that the Horicon Town Board acting as Local Board of Health, based on the receipt of a set of stamped plans from KSPE LLC, and the \$100.00 variance fee, does hereby grant a variance, pending approval by the NYS Department of Health, to install a wastewater disposal system (Eljen GSE Trench System) at 7296 State Route 8 in Brant Lake (Tax Map #72.6-1-2) because the strict application of the minimum setback requirements, or the minimum lot size requirement, would result in a specified practical difficulty to the applicant. Further, the alternative proposed would not be materially detrimental to the purpose of this regulation, or to the property or natural resources in the area in or near the site of the proposed individual sewage disposal system, or otherwise

conflict with the description, purpose, or the objectives of any plan or policy of the Town, and that the alternative proposed is the minimum variance which would alleviate the specified practical difficulty as found by the Board to affect the applicant.

#### Discussion on correspondence:

Handicap access to Library: Supervisor Geraci said he and Councilmember Francisco looked at the building and there is handicap access into the Library both in front of the building and in the rear. Councilmember Francisco said Joan had mentioned something about an automatic door, but he is not sure that is what she is talking about as the letter does not specify what type of handicap access.

Palisades Road: Supervisor Geraci said Kevin Hajos, Superintendent of Public Works, had provided a written response to the people that had voiced concerns over some of the work being done on Palisades Rd. Supervisor Geraci clarified that Palisades Road is a County road, and over the next several years the County hopes to re-do the entire road.

Reports: Town Clerk, Justice, Zoning, Assessor, NWEMS, Transfer Station, Library, Historian, Historical Society

#### **Supervisor's Report** – see copy attached.

Supervisor Geraci said there was a request to DEC to consider modifying the hours at the Brant Lake Boat Launch, specifically closing it for certain periods of the day. There are a couple of reasons for this; one is the ProcellaCor treatment which will begin soon, and the thought is if the hours could be reduced to just when stewards are there it might help the lake in general. He said DEC was not in favor of this because the lake is taxpayer funded, it is a public body of water not a private lake, and people other than those on the lake can use it. So, the launch will not be closed, and the hours will not be modified.

Councilmember Francisco asked if the number of boats on the lake could be limited on the days of the ProcellaCor application; Wayne Butler said no, the areas that are being treated will be buoyed off.

Supervisor Geraci spoke about the lack of broadband access in parts of the Town. He explained the cost to provide access to these areas would be hundreds of thousands of dollars. Supervisor Geraci said there is state funding coming down from the Federal government for broadband, but it is very difficult to access. He has made an official request to Warren County to seek funding for all in the County. He said the Board of Supervisors is going to have a workshop meeting specific to this issue.

Councilmember Francisco said he wants a resolution to move the watering tub rock. He said the SLPD is fine with the Town moving it. Councilmember Francisco said he spoke to the Historical Society about putting it at the Museum. Supervisor Geraci asked Sylvia Smith if the Historical Society is in favor of this. She said the HHS Board did vote to take the rock, however, they do need the full history of the Watering Tub as this is not the original rock. Mrs. Smith said they will also need to meet with HS Granger to decide where it can be placed. There was additional discussion related to the history of the rock.

Comprehensive Plan update: Supervisor Geraci said the Town was awarded a grant to develop a new Comprehensive Plan. He said in the next few months he will be providing more information on this process and will be looking for people interested in being on the committees that will work on this plan. He said the LCLGRPB is going to be the contractor for this plan, and Allison Gaddy, who is the point person, will be at the June meeting to discuss the process.

Brant Lake upper dam update: Supervisor Geraci said he and HS Granger had a meeting with Laberge to discuss the upper dam. He said although the dam is supposed to be automatically controlled it is currently being controlled manually. He said Laberge will be doing some work on this.

#### **New Business**

Condition of Town Hall roof: Supervisor Geraci said Councilmember Francisco brought up the fact that the Town Hall roof does not look very good. Supervisor Geraci said he had Cedarwood Engineering do an assessment of the roof and they found the roof itself to be in good shape, however the fascia is not. He said they will be getting estimates to repair the fascia.

#### Privilege of the Floor

- -Jean Olson said the lake level has been a source of contention for years. She thanked the Town for staying involved in the Adirondack Association of Towns and Villages; Horicon was one of the founding members of this association. Mrs. Olson said the Town gave the State of New York the boat launch; she believes there is a stipulation in the contract that allows the Town to take it back. Supervisor Geraci said he is not sure if the stipulation to take the launch back is still in the contract but he will review this.
- -Wayne Butler first thanked Councilmember Olson for his years of service to the Town. Mr. Butler then gave an update on the education plan regarding the ProcellaCor treatment and expects this to start next week. Lastly, he noted some of the work the County is doing on Palisades Road is to actually manage some of the water run off from going into the lake.
- -ZA Craig Leggett told Councilmember Olson he will be missed, and he has served the Town well over the years.
- -Councilmember Carlozzi thanked Councilmember Olson for his years of service, noting she is the third Carlozzi to have been able to work with him. She told him he will be missed and his legacy will go on.

-Diane Dreyer expressed concern about the amount of trash left around from Food Truck Fridays. She suggested the vendors be asked to use recyclable food containers and the Town to use clearly marked recyclable receptacles. He asked if her concern is recycling or the volume of trash. She said she is concerned that when the recyclable receptacles are full, people start throwing bottles in the garbage. Barb French said several of the volunteers empty the garbage and recyclable receptacles throughout the night, but you cannot monitor everyone. Ms. Dreyer asked that the vendors encourage people to handle their trash properly. Supervisor Geraci said that really is not the vendors responsibility. Sylvia Smith noted that at the end of the night it is amazing that there is no garbage on the grounds. She added that the volunteers and the vendors do a very good job keeping everything picked up. Teri Schuerlein said from what she has seen most of the vendors use cardboard or recyclable containers not styrofoam.
