Supervisor Geraci opened the regular meeting at 6:00pm.

Supervisor Geraci welcomed guests and noted the first order of business would be the administering of the Oath of Office to the newly appointed Town Board members. The Town Clerk administered the Oath of Office to:

Recognition of former Town Board member Robert Olson:

Assemblyman Matt Simpson spoke about Bob Olson's involvement with so many things in the Town of Horicon over the years. He said in honor of Bob, both he and Senator Dan Stec passed resolutions in their respective houses recognizing former Councilman Robert Olson for his many years of service to the Town of Horicon; they then presented Bob with the resolutions.

Senator Stec said Bob has been a good friend of his, a good friend to the Adirondacks, and a good friend to Warren County for many years. He said to be a Board member for twenty-six years is a lot to give, and certainly represents a life of service.

Supervisor Geraci said it has been a pleasure to serve with Bob. He then presented Councilman Bob Olson with a plaque in honor of his devoted commitment to the community throughout his years of service.

Bob Olson thanked everyone and said he is tremendously humbled by this. He said he is proud to have been a member of this Board and to have had the opportunity to serve the Town.

Allison Gaddy, Principal Planner LCLGRPB - Comprehensive Plan update:

Supervisor Geraci explained that the Town's Comprehensive Plan, which was adopted back in 2010, is in serious need of being updated. He said the Town was awarded a grant through the NYS Department of State Smart Growth Comprehensive Planning Grant Program. He said what is needed to move forward is for people to volunteer to be on the Comprehensive Plan Committee; he said they need participation and opinions from the community. Allison Gaddy, Principal Planner of the Lake Champlain Lake George Regional Planning Board explained that a Comprehensive Plan is a document that provides a blueprint for the future. She said it is recommended that the plan be updated every 5 to 10 years to account for the changing characteristics and needs of the community. To do this, Ms. Gaddy said they are looking for an 8-12 member committee that encompasses a broad cross section of the community to work on updating the plan. She then gave an overview of what the process of developing the plan will involve.

Supervisor Geraci asked Sarah Brugger to explain the Pro-Housing Community program.

Ms. Brugger explained that designation as a Pro-Housing Community allows the Town to apply for grants to address the lack of adequate housing in the community.

Old Business

Status of Lifeguards: Supervisor Geraci said, as of now, there are no lifeguards for the Brant Lake beach, and there is just one lifeguard for the beach in Adirondack. He said the Town has advertised for months with no response; lifeguards are very difficult to find. He said if anyone is interested in lifeguarding, or knows someone who might be, please call the Town office for more information.

Watering tub update: Supervisor Geraci said there was a discussion last month about moving the Watering Tub rock to the Horicon Museum. He said, in summary, after looking at everything the Historical Society has decided not to take the Watering Tub rock. Councilmember Francisco said at the last meeting the Board passed a resolution to move the Watering Tub rock from the SLPD property to the Horicon Museum. Sylvia Smith, President of the Horicon Historical Society, said the Historical Society had said they would take the Watering Tub rock, however, once they looked at it, they realized it was not possible because they have no place to put it. Mrs. Smith said instead, they are offering to put a marker on the Watering Tub rock recognizing the Towns of Schroon Lake, Chestertown, and Horicon, put the date on it, and leave it where it is. She said the Historical Society apologizes but they have rescinded their resolution to accept it.

Supervisor Geraci asked, at this point, that the Town Board work in partnership with the Historical Society on their offer. He said a plaque would be nice and very appropriate. Councilmember Francisco said he has no problem with what happens with the rock, but if the Town wants to gift it to the SLPD they need their approval.

Supervisor Geraci said without any disagreement then, the Town will continue to work with the Historical Society on a design for the plaque.

Status of 2024 significant projects: Supervisor Geraci gave an update on the status of the significant projects the Town is working on.

New Business

Horicon Tourism video: Supervisor Geraci showed the video for the Town of Horicon that was created by Margaret Holmes for Lake George TV. He also acknowledged and thanked Carl Heilman for the use of his photos in the video.

He noted one last thing, the winter edition of the BLA Brant Laker won #1 in NYS for NYS Federation of Lake Associations.

- -Dianne Dreyer lasevoli said there are lights at Point O' Pines that are on all night long and asked the Town Board if they can do anything about this issue. Supervisor Geraci said he will talk to them and get more information.
