### Ethan Gaddy – Warren County Planning Department:

Supervisor Geraci said there are several issues that have been discussed for some time which are septic systems and the lack of broadband. He said Ethan Gaddy is here to give an update on these topics.

# HORICON TOWN BOARD REGULAR MEETING

Mr. Gaddy first explained the septic system replacement program. He said since 2021 Warren County has been administering funds from the EFC (Environmental Facility Corporation) for the septic system replacement program which will cover up to 50% of the system replacement cost up to \$10,000. He said Warren County Planning & Community Development is continuing to apply for additional funding, and he encouraged everyone to apply. He said this will help them show there is a need for their allocation to be increased based on the number of applications received. Mr. Gaddy said the application can be filled out online at <a href="https://warrencountyny.gov/planning">https://warrencountyny.gov/planning</a>.

Councilmember Schuerlein asked if someone fills out an application but has to replace their septic while they are waiting for approval would they still be able to get funding. Mr. Gaddy said it is their understanding that if an application has been submitted and the person is eligible for the program it is likely they would be reimbursed.

Councilmember Francisco asked if a system needs to be tested or is it the age of the system that determines if it qualifies. Mr. Gaddy said generally they receive the application and then Buildings and Codes reviews the project to be sure there is evidence of a need to replace it.

Supervisor Geraci asked if there is a priority based on the distance of a system from the water. Mr. Gaddy said under the DEC program there is, but under other funding guidelines there is no geographic location requirement.

Mr. Gaddy said the most important thing is for people to fill out the application.

Mr. Gaddy then spoke about the issue of broadband. He said the federal government has earmarked millions of dollars to upgrade broadband, but it takes a very long time for this money to get down to the local level to get the work done. He said they are looking at doing a pre-application process to solicit interest in using something like Starlink or another satellite-based option for internet. He said this application process would allow them to determine if people would be interested in participating in the program which would provide the hardware and then the participant would pay for the monthly service. Doing this pre-application process would allow Warren County to determine what the cost for the program would be. Mr. Gaddy said the goal is to find a far more cost-effective option for broadband.

### Old Business:

### Community Center roof fascia repair and Museum Annex repairs and painting:

Supervisor Geraci said the bids for both projects were opened at the November 21<sup>st</sup> meeting. The engineer reviewed the bids, and they think there are some amendments that could be made for both projects. Supervisor Geraci said, after his presentation to the Town Board on January 16<sup>th</sup>, the engineer will produce new specs for both projects. He said once the new specs are ready, and the Board has reviewed the information, the projects will be put out for bid again; he noted these will be spring projects.

#### New Business:

Supervisor Geraci explained that the eleven windows at the Heintzelman were stained, and now they want them varnished. Curt Morehouse submitted a proposal to apply one coat of varnish at a cost of \$1,100, or two coats at a cost of \$2,200. Supervisor Geraci noted the work will be covered by the grant from Adirondack Architectural Heritage. Councilmember Francisco said they will need to see what it looks like after the first coat dries to determine if a second coat is needed.
