WHEREAS, the Town Board of the Town of Horicon has by Resolutions encouraged the Historical Society to research and apply for planning, implementation and capital grants for Historical Society programs and projects including toward achieving use of the Adirondack Union Church as said Museum facility, AND

WHEREAS, the Town of Horicon and the Historical Society have been advised that grants may be available in 2015 for these purposes and the Historical Society wishes to apply for this grant funding, for which applications for such require or are greatly enhanced by Resolutions of support by the Town Board of the Town of Horicon, NOW, THEREFORE BE IT

RESOLVED, that the Town Board of the Town of Horicon does hereby encourage, authorize and support the Horicon Historical Society grant funding efforts including under federal, New York State and other planning, implementation and capital grant programs as may be available for Historical Society programs and capital projects including creation of the Museum facility at the Adirondack Union Church.
