# HORICON TOWN BOARD REGULAR MEETING

OCTOBER 15, 2015 7:00 PM

-Councilperson Smith told the Board the Lazy Moose has donated all the mums to the Town, a follow-up email has been sent to Selective Insurance advising them the work on the playgrounds is expected to be done in the spring, the fall clean-up in the cemeteries will be done next week, and she and Supervisor Simpson plan on meeting with the Historian to discuss priorities for the upcoming year. Lastly, Councilperson Smith noted there will be a Veterans Concert on November 15<sup>th</sup> at the Glens Falls High School at 3:00 pm for Veterans and anyone else that wishes to attend.

-Supervisor Simpson told the Board he has confirmation from Senator Little that the Town has been awarded the \$100,000 grant for the 1881 Union Church. He also noted the County is continuing their work on the lower dam, and they have begun removal of the bridge over the upper dam.

## Old Business...

<u>Brant Lake Survey:</u> Supervisor Simpson said he does not feel any action should be taken in regards to the Brant Lake Survey that was proposed by the Brant Lake Association. Councilperson Olson agreed noting that if the Brant Lake Association wants to do another survey they certainly can, but he feels issues are being addressed as they come up and the Town is responsive to the taxpayers.

<u>Brant Lake Taxing District:</u> In regards to the discussion on a possible Brant Lake taxing district last month, Supervisor Simpson has had Assessor Christine Hayes identify properties that have lake access. She said her records indicate there are approximately 374 parcels that would be affected by a taxing district. He asked the Board to review the information, and noted they need to do some calculations and work out a plan to determine if a taxing district would make sense. Supervisor Simpson and Councilperson Olson will work out the numbers and present to the Board.

## **New Business...**

<u>Fleetmatics:</u> Supervisor Simpson told the Board he had been contacted by a company that offers a fleet management program. He explained the program does a number of things including tracking maintenance and providing data on vehicle location, speed, idle time, etc. The cost is \$35.00 per vehicle per month. He noted that he and Councilperson Hill were in favor. Councilperson Olson and Councilperson Higgins did not feel it was necessary and thought it was too costly. No action was taken.
