Local Board of Health...

A Motion was made by Councilperson Hill, seconded by Councilperson Smith, to go into session as the Local Board of Health. The Board moved into session as Local Board of Health at 7:00 PM.

Public Hearing - Septic Variance at 248 E. Shore Dr, Adirondack / tax map #36.3-3-2 / Hughes

-Tom Hutchins, Hutchins Engineering, said he modified the septic plans per Cedarwood Engineering's recommendations as follows: 1) include Schedule 80 PVC piping for installation of the tanks (although the tanks are not being installed in an area subject to regular vehicle traffic); and 2) the holding tank detail now indicates tank backfill shall be compacted in lifts of 12" to minimize potential settling around tanks and piping. ZA Steen said he has not received any comment from the neighbors. He said he is very satisfied with the proposed system as it is the best option available. Supervisor Simpson asked what, if any, alternatives there were. Mr. Hutchins said the alternative would have meant imposing on both the owner's well and the neighbor's well which would have required four different variances, therefore, he decided to go with the holding tanks.

There being no further comments the Public Hearing was closed at 7:06PM.

RESOLUTION #135-2017

Councilperson Olson and Councilperson Higgins introduced Res. No. 135 and moved its adoption:

RESOLUTION TO GRANT VARIANCE FOR AN ALTERNATIVE SEPTIC SYSTEM AT 248 EAST SHORE DRIVE

RESOLVED, that the Horicon Town Board acting as Local Board of Health, based on the receipt of a set of stamped plans from Hutchins Engineering (project #291203-01), and the \$100.00 variance fee, does hereby grant a variance for an alternative septic system at 248 East Shore Drive, Adirondack, NY (Tax Map #36.3-3-2) because the strict application of the minimum setback requirements, or the minimum lot size requirement, would result in a specified practical difficulty to the applicant. Further, the alternative proposed would not be materially detrimental to the purpose of this regulation, or to the property or natural resources in the area in or near the site of the proposed individual sewage disposal system, or otherwise conflict with the description, purpose, or the objectives of any plan or policy of the Town, and that the alternative proposed is the minimum variance which would alleviate the specified practical difficulty as found by the Board to affect the applicant.

Septic Variance request at 211 E. Shore Dr, Adirondack / tax map #36.3-3-12.1 / Centofante:

Harold Berger, P.E. explained the septic system proposal for 211 E. Shore Dr. in Adirondack. He said the proposed system will consist of one 1,500 gallon septic tank with a Presby absorption bed for a five bedroom home. Mr. Berger noted the design is in accordance with the NYSDOH handbook. He said the proposed absorption bed has a separation distance of 68' which does not meet the required 100' separation distance to the mean high water mark of the lake. Mr. Berger also noted soil modifications under the absorption bed will be needed to meet the necessary percolation rate. He added that they have met the 100' separation distance to the owner's well and the adjacent well. Councilperson Olson asked if the system is designed for a five bedroom home as proposed, and Mr. Berger said yes.

Correspondence to the Board...

-Kevin Reeth RE: Request to change seasonal use classification on 900 feet of Bean Road <u>Discussion on Correspondence</u>: Councilperson Olson said he spoke with both the Highway Superintendent and the Foreman, and they are not in favor of opening the 900-foot section of Bean Road citing numerous issues with the undertaking. Councilperson Olson said he understands the situation; it was fine as seasonal use while the Reeth's used the property for the past twenty-five years, but now it is a detriment to them in terms of selling their property. However, he does not feel the Town should take the road over for the sole benefit of the Mr. Reeth. It was noted that adjoining landowners are not in favor of the use change. The Board agreed they are not inclined to grant Mr. Reeth's request.

Resolutions...

2018 Preliminary Budget Discussion: The Board discussed two items in the proposed Preliminary Budget. The first item discussed was the Highway Superintendent salary increase. Supervisor Simpson had initially proposed \$49,561 in the tentative Budget, and at the workshop meeting the Board agreed to increase it to \$51,000. Supervisor Simpson said he was in favor of the additional salary increase, however, in a salary comparison to other Towns he is now recommending the salary be set back at the original amount he proposed of \$49,561.00. Councilperson Olson said he put more thought into this after the workshop meeting and agrees with Supervisor Simpson. Supervisor Simpson stressed this is by no means a reflection on HS Granger's job performance. The Board agreed to set the salary back to the \$49,561.

OCTOBER 19, 2017 7:00 PM

Second up for discussion was the BTI Program. Supervisor Simpson said the one-year contract would be \$19,900, and the three-year contract would be \$19,500 per year. Councilperson Olson asked if there is an escape clause in the three-year contract. Supervisor Simpson said the contract references arbitration in the event of a dispute. Counselor Schachner said this does not constitute a termination clause, and added he never recommends arbitration. Supervisor Simpson said the Board has the option to revise the contract. Councilperson Hill said there is no way for the Board to know if the work has been done. Councilperson Higgins said he is not in favor of the program unless it is done properly. He said he is against spending \$20,000 for BTI when there are projects that need attention like the Community Center roof and driveway, the garage roof, the Town roads, and other maintenance projects that are not getting done. Councilperson Smith expressed concern over the Board's inability to make sure the program is done properly, and asked if Ms. Vanselow could be required to submit a treatment map. Councilperson Olson said the quality control is up to the Board, and he feels it is a worthwhile program. Councilperson Higgins reminded the Board they have been through this before and there is no way to follow up. Councilperson Smith said she would like to know how the Board plans to follow-up and there was no response.

Motion made by Councilperson Olson, seconded by Supervisor Simpson, to sign a three-year contract for BTI amended to include an escape clause, removal of the arbitration clause, and a treatment map.
