#### **RESOLUTION #145-2014**

Councilperson Olson and Councilperson Hill introduced Res. No. 145 and moved its adoption:

### **RESOLUTION TO ADOPT THE 2015 HORICON BUDGET**

WHEREAS, a public hearing was held on October 23, 2014 at 6:00 PM at the Horicon Community Center on the Preliminary Budget for the year 2015, AND

WHEREAS, comments were invited from the public either for or against said budget, NOW, THEREFORE BE IT

RESOLVED, that the Preliminary Budget will be the adopted Budget for 2015, with the General Fund Appropriations of \$1,856,822.00 less anticipated revenues of \$1,606,050.00 and an unexpended balance of \$158,989.00 leaving an amount to be raised by taxes of \$91,783.00. Total Highway Fund Appropriations of \$1,351,002.00 less anticipated revenues of \$804,528.00 and an unexpended balance of \$91,783.00 leaving an amount to be raised by taxes of \$454,691.00 and a total budget of \$3,207,824.00, BE IT FURTHER

RESOLVED, that the amount for the Horicon Fire District is \$217,973.00 to be raised by taxes and the Schroon Lake Park District is \$5,944.00.
