Rich Nawrot asked about the Schroon Lake Park District budget amount. Supervisor Simpson explained the line item.

Vince Blando spoke in favor of continuing to budget monies for Schroon Lake milfoil control from year to year. Supervisor Simpson noted the Board plans on continuing this in the future.

There was brief discussion on the removal of the Black Fly program from the Budget. It was noted that it is costly for what is done. Supervisor Simpson pointed out that the Town would have to go over the tax cap to implement the Black Fly program. He said he believes it is about prioritizing, and he noted several upcoming expenditures the Town is facing that must come first. The Board agreed not to include the program in the Budget.

Supervisor Simpson this Budget has an overall increase of one percent.

There being no further comments, Councilperson Olson made a Motion, seconded by Councilperson Hill, to close the Public Hearing. The Public Hearing was closed at 7:25 PM.

RESOLVED, that the Preliminary Budget will be the adopted Budget for 2016, with the General Fund Appropriations of \$1,839,389.00 less anticipated revenues of \$1,654,817.00 and an unexpended balance of \$184,572.00 leaving an amount to be raised by taxes of \$0.00. Total Highway Fund Appropriations of \$1,406,571.00 less anticipated revenues of \$851,751.00 and an unexpended balance of \$0.00 leaving an amount to be raised by taxes of \$554,820.00 and a total budget of \$3,245,960.00, BE IT FURTHER

RESOLVED, that the amount for the Horicon Fire District is \$217,973.00 to be raised by taxes and the Schroon Lake Park District is \$5,938.00.
