<u>YMCA Outreach Center</u>: Brian Bearor and Tammy Laguerre, from the YMCA Outreach Center, were in attendance to update the Board on the exciting things that are happening at the Center and to talk about the programs they are developing.

### Committee Reports...

-Gary Frenz reported to the Board on the NWEMS. He said they are currently in the process of reorganizing and hope to be ready with that by the first of the year.

- -Councilperson Sylvia Smith said another Occupancy Tax application has come in, and noted there will be a meeting to prioritize the applications for the upcoming year. She listed all of the projects that have been completed in the Town this year. She explained that the playground project is complete, although the playground had to be moved to meet the specifications of the project. She will be meeting with the individuals from the County around the first week of December regarding the Heintzelman Library. She has been asked to note the Adirondack Shindig will be held on August 12, 2017. Lastly, Councilperson Smith said she and Councilperson Olson interviewed five applicants for the Landfill position and wish to recommend Steve Smith for the job.
- -Supervisor Simpson said a light is needed for the playground and possibly a security camera. On the Heintzelman Library he noted that he is still waiting on the plans from Cedarwood Engineering. Lastly, he said the upper dam repair is complete, the bridge is complete, and supposedly the lower dam has been repaired.
- -Councilperson Olson said the new Zoning Law has been distributed to the members of the Zoning and Planning Boards and it is now online as well. He feels the current price of \$10 per copy for the Zoning Law is too low and suggested raising the price. There was brief discussion on what the price should be. **RESOLUTION #165-2016**
