<u>2) Public Hearing - Septic Variance at 712 East Shore Dr., Adirondack / tax map #20.13-1-23</u> Tom Jarrett, Jarrett Engineers, briefly reviewed the proposed system once again. ZA Steen stated there were no comments from surrounding landowners. There were no comments from the audience.

Committee Reports ...

-Councilperson Sylvia Smith reported the Occupancy Tax application is ready. She said a request came in from North Country Arts for support of emerging artists in the amount of \$250.00. She and Councilperson Hill have finalized a sign design for the Town at a quoted price of \$2,985.00. Councilperson Smith noted the Committee is still working on a name for the Horicon summer event, and they hope to have the details wrapped up at their next meeting. She said the specs on the playground are complete, but the pricing may need to be updated. The ad has been placed for a Lifeguard for the Brant Lake beach and the school has been notified of the opening. Lastly, Councilperson Smith noted the dedication of the Ellsworth Reading Room at North Warren Central School will be March 12th.

-Councilperson Hill said he feels there should be something more than the small box for the Boat Launch for the Stewards. He said he feels there should be a small building, approximately 8'x10', built for them to get out of the weather and store their things. There was brief discussion on this and the Board will hold off on doing anything permanent until after DEC paves the parking lot.

-Councilperson Olson advised the Board of ongoing issues the Highway Department is having with a logger on a Town Road, and suggested a letter be sent to the property owner in an effort to get the

logger to abide by rules and regulations. He noted that NYS DOT has been contacted about the possibility of putting a turn lane on Route 8 onto Town Shed Road, but the Highway Dept has learned this will not be an option. Therefore, he said the Highway Department cleared some trees to create a sight line for the trucks as they pull out onto Route 8. Lastly, Councilperson Olson said HS Smith has located a used vibratory roller that can be used for compacting base and blacktop that he would like to take a look at. He is asking for approval from the Board for the Highway mechanic and one other person to go down near Long Island to look it over. The Board had no objection.

-Supervisor Simpson said he just returned from the Association of Towns training in New York and discussed a few of the things he learned. He also discussed the unused Occupancy Tax funds, noting it does not do the Town any good to accumulate the funds unless there is a project. He said he would like to see the surplus occupancy tax funds used for a plan for the park/recreation area in Adirondack.
