He explained that NYMIR will cover the Town at a premium of \$4,800.00 less than Selective; however, NYMIR will not cover any damage from the Dam downstream in the event the dam fails. Selective Insurance will cover the Town with no exclusions. Additionally, he said the Town can save \$1,004.00 with Selective if they go from a \$500.00 deductible to a \$1,000.00 deductible. RESOLUTION TO AUTHORIZE CONTRACT WITH GLENS FALLS ANIMAL HOSPITAL

RESOLVED, that the Town Board of the Town of Horicon does hereby authorize Supervisor Simpson to sign the contract with Glens Falls Animal Hospital for the handling of unidentified dogs. This agreement will be in effect for the 2014 calendar year.

<u>Dam Update</u>: Supervisor Simpson said he has received a packet from Laberge on the dam and he is getting positive feedback on the progress. He noted that hopefully within the next month the Town should have an answer as to whether the Dam will be changed from a Class C dam to a Class B dam.

<u>Landfill Monitoring Reduction proposal</u>: Supervisor Simpson said he met with Cedarwood Engineering regarding a Landfill monitoring reduction proposal. The Town would be able to test yearly rather than quarterly which would save the Town thousands of dollars over time. The cost to implement the program with Cedarwood is \$2,500.00 and Supervisor Simpson noted that DEC may require some work to be done on the wells, but over time this will be a cost savings.

RESOLUTION #55-2014

Messrs. Olson and Smith introduced Res. No. 55 and moved its adoption, all Ayes:

RESOLUTION TO MOVE FORWARD WITH CEDARWOOD ENGINEERING

RESOLVED, that the Town Board of the Town of Horicon does hereby authorize the Supervisor to move forward with Cedarwood Engineering on the Landfill monitoring reduction program.

<u>Water Test Results</u>: Supervisor Simpson said the water test results from the Landfill and Highway Garage came back. He said the Highway Garage results were fine, but the Landfill results showed high levels of several different elements and the water should not be consumed. The Board agreed that a notice to this effect must be posted at the Landfill.

Committee Reports:

-Councilwoman Smith reported that they have submitted the 2013 North Warren County Celebration, in conjunction with the Town of Chester, for the Adirondack Park Excellence contest for Best Event. She said they are also working on some ideas for the Community Center including converting the old Tax Office into an office and storage space for the Food Pantry and cleaning supplies. They are also looking into the fee that is charged to rent the meeting room. Councilwoman Smith said they are going to be working on the Cemetery maps as well as making some improvements to the Cemetery.

-Councilwoman Smith and Supervisor Simpson noted that they had attended the training in New York and found it very informative.

-Councilman Olson reported that the Brant Lake Winter Carnival was a huge success. He also said that they had held their first Horicon Day meeting and Alonzo Fireworks has agreed to do the fireworks display again.

-Supervisor Simpson noted that Karen Burka, Court Clerk, has secured a grant for the Justice Office of \$1052.00, and she is working on additional grants.

Privilege of the Floor...

-Jane Smith noted that it was good to hear Committee reports from the Board members.

-Paul Holmes said he had looked over the health insurance practices and asked if there were options available in terms of sharing costs with other Towns. Supervisor Simpson said it is something the Town can look at and he will research it. Harry Balz noted that the town could look into whether converging with the schools on health insurance might be an option.

Executive Session

Councilman Olson made a motion, seconded by Councilman Higgins, to move to Executive Session to discuss possible litigation. The Board moved to Executive Session at 8:25 PM.

The Board returned from Executive Session at 8:45 PM and Councilman Olson made a motion to return to Regular Session, seconded by Councilman Hill, all in favor. The Board discussed possible litigation, no action was taken.
