<u>Agreement for Expenditure of Highway Money:</u> HS Smith gave the Board a copy of his proposed Expenditure Agreement. <u>Fuel and Propane Bids</u>: The Town Board advertised for bids for heating oil and kerosene for Town buildings and also for propane for the Highway Garage, and two bids were received and opened on May 15<sup>th</sup> at 7:10 pm. Supervisor Simpson read the bids which were received from Mountain Petroleum and Buckman's Family Fuel Co.. Harry Balz asked if the Town had researched the OGS pricing.
