## Local Board of Health...

A Motion was made by Councilperson Olson, seconded by Councilperson Higgins, to go into session as the Local Board of Health regarding septic variances. The Board moved into session as **Local Board of Health** at 7:00 PM and Supervisor Simpson opened the Public Hearing.

## Public Hearing for Septic Variance at 580 East Shore Dr. / tax map #19.4-2-12 / Dermody

Zack Monroe, Bret Winchip Engineering, reviewed the proposed septic and the variances they are seeking. ZA Steen noted the neighboring property owners have indicated they have no issues with the septic variance request. Councilperson Olson asked several questions regarding the plan. He then suggested the proposal be referred to Cedarwood Engineering for their opinion; Councilperson Hill said he supports this recommendation.

Bill McGhie asked how big a tank the property owner plans on putting in, and asked if there may be a more efficient option such as a Norweco. ZA Steen said based on the specifics a Norweco system would not be necessary, the proposed system would be sufficient.

# Request for septic variance at 3573 East Schroon River Rd / tax map #70.15-1-15 / McDonald

ZA Steen gave the Board a brief history of the project at 3573 East Schroon River Rd and noted there is currently a hardship due to the circumstances. In light of this, ZA Steen asked the Board to consider expediting the process by deeming the application complete pending receipt of an accurate survey showing accurate separation distances prior to the Public Hearing. ZA Steen noted this does require seventeen different variances, and what is being proposed is an Aerobic Treatment Unit with an Eljen Bed System which adds more protection. He said Mr. McDonald has already agreed to reimburse the Town for the referral to Cedarwood. The Board will set the Public Hearing, and in the meantime, refer the application to Cedarwood Engineering for review prior to the Public Hearing pending receipt of the necessary site plan.

# **Committee Reports:**

-Gary Frenz updated the Board on the NW Emergency Squad. He noted there are a few problems but he, Supervisor Simpson, Bob Olson, and the Town of Chester Supervisor are working to resolve them.

-Councilperson Smith said the Town currently has no buildings on the National Historical Registry, but the Town can request the Heintzelman Library be considered for placement on the registry. She explained the Warren County Historian has agreed to help the Town move forward with the process if the Board is agreeable. The Board agreed to move forward with this. Councilperson Smith noted that the repairs currently needed on the building must be done in stone or there will be no chance of it making the National Registry. Councilperson Olson said he has contacted three stone masons asking for quotes to repair the building to the way it was. He has received one proposal so far.

Councilperson Smith explained the survey stakes on the left side of the driveway in Underwood Cemetery are missing and asked if the surveyor could be contacted to replace them. The Board agreed this should be done.

# **RESOLUTION #127-2016**

Councilperson Olson and Councilperson Smith introduced Res. No. 127 and moved its adoption:

# **RESOLUTION TO EXPEND CEMETERY FUNDS**

RESOLVED, that the Town Board of the Town of Horicon does hereby authorize the replacement of the missing survey stakes in Underwood Cemetery and the funds are to be taken from the Cemetery Maintenance account. Ayes: 5 (Olson, Smith, Higgins, Hill, Simpson) Nays: 0

Councilperson Smith commended all the work that has been done on Beautification. On this topic, Supervisor Simpson explained there is grant money available to do a grant erosion project which would beautify approximately 150 ft along Market Street. He explained this would delay the playground project until spring, but the grant money is only available through the end of the year. He currently has Warren County Soil and Water working on the permit for this. Councilperson Higgins said he feels this is a good idea, but the playground needs to get done; it keeps getting pushed out but it needs to be a priority. Councilperson Smith said she would like to see both projects done now. She noted that new equipment is also needed for the playgrounds so if it is not going to get done now, then the Board needs to have a plan in place to get it done in the spring. Comments from the Board members indicated it is feasible to do both projects now.

Lastly, Councilperson Smith said she and Supervisor Simpson met with the Library Trustees and a representative from SALS on how things need to be handled. She said there will be more information to come.

- -Councilperson Hill said he has spoken to Cindy Hilton about putting the Brant Lake sign on her property. The new lawnmower will be delivered tomorrow, and the older one is now in need of repair. He has contacted four people for quotes on seal coating and one has replied. Councilperson Hill told the Board that the individual responsible for damaging the light pole behind the Community Center was told by the Court she would have to make restitution. He also said he has had no response from the individual he contacted to repair the tennis courts.
- -Councilperson Olson said the Landfill loader bucket has been repaired at a cost of \$670.00. He noted the roof at the Heintzelman Library has been shored up temporarily until it can be repaired. Lastly, he said work on Duell Hill road is going well and paving is expected to be done in a couple of weeks.
- -Supervisor Simpson said he has been in contact with Ed Bartholomew and the Department of State to try and figure out when the foundation on the Union Church can be done.

#### **Old Business:**

<u>New Proposed Zoning Law:</u> Supervisor Simpson explained the Public Hearing for the proposed Zoning Law was held on August 16<sup>th</sup>, and now the Board needs to complete the Full Environmental Assessment Form part 2. The Clerk read the eighteen questions aloud and the Board responded 'no' to all eighteen questions.

#### **RESOLUTION #128-2016**

Councilperson Olson and Councilperson Higgins introduced Res. No. 128 and moved its adoption:

# RESOLUTION OF SEQRA NEGATIVE DECLARATION FOR REVISED TOWN ZONING LAW

WHEREAS, the Town Board has created a revised Town of Horicon Zoning Law; and

WHEREAS, Public Hearings were conducted on July 7TH and August 16TH to review the proposed revised Zoning Law including the addition of "group camp" as a Conditional Use in the R-1 Zoning District; and

WHEREAS, the Town Board also decided to further amend the new Zoning Law by revising the proposed commercial boat storage regulations; and

WHEREAS, the Town Board wishes to obtain Adirondack Park Agency approval of the new Zoning Law in order to maintain our APA-approved Local Land Use Plan; and

WHEREAS, the Town Board prepared Part 1 of the State Environmental Quality Review Act ("SEQRA") Full Environmental Assessment Form ("EAF") and was duly designated as Lead Agency for review of the amended Zoning Law under SEQRA; and

WHEREAS, the Town Board has reviewed and fully considered the proposed revised Zoning Law and Part 1 of the EAF and has completed Parts 2 and 3 of the EAF; NOW, THEREFORE, BE IT

RESOLVED, that the Town Board hereby finds that adoption of the revised Zoning Law will not have a significant adverse impact on the environment and authorizes the filing of the completed EAF as the SEQRA Negative Declaration – Notice of Determination of Non-Significance; and be it

FURTHER RESOLVED, that the Town Board hereby reaffirms its acceptance of the amended Zoning Law including the revisions relating to group camps and commercial boat storage and its authorization to refer the amended Zoning Law to the APA for its formal review; and be it

FURTHER RESOLVED, that the Town Supervisor, Town Clerk, Town Zoning Officer and Town Counsel are hereby authorized and directed to take any and all further action as necessary to effectuate the intent of this Resolution.

<u>EZ Marine Lease</u>: Councilperson Olson said he met with Bernie Hill, EZ Marine, and told him the Town Highway needs to use the property he leases from the Town. He said in light of this the Town wishes to terminate the lease and it will be necessary for Mr. Hill to move the boats from the property. Councilperson Olson explained

to Mr. Hill the lease could be terminated in thirty days, and he said Mr. Hill expressed concern that he would be able to remove the boats that fast. There was discussion on the matter and the Board agreed to send a letter to Mr. Hill advising the lease will be terminated, no more boats are to be brought onto the property, and any remaining boats must be removed by September 30, 2016.

<u>Septic at St. Theresa's:</u> Supervisor Simpson said he and Councilperson Hill spoke to Ed Ragule, owner of St. Theresa's, and advised him that the Town will require an annual contract and an annual fee for use of the septic. They explained this was to have been done originally with the previous owner but it was not; Mr. Ragule understood and is agreeable to this. The Board agreed the annual fee will be \$20.00 per month. Supervisor Simpson said Town Counsel will draft the contract. Supervisor Simpson noted going that forward the contract will only be with the current owner for current use; if there are any changes in either the contract will be reviewed at that time.

# **New Business:**

<u>Town Health Officer</u>: Supervisor Simpson noted Gary Scidmore has resigned as Town Health Officer and the Board needs to appoint a replacement. He said he spoke to Lyn Keil who said she would be interested in the position, and he asked the Board if they would like to appoint Ms. Keil. Councilperson Smith said she feels Ms. Keil should be interviewed before making an appointment. The Board agreed Councilperson Smith and Councilperson Olson will meet with Ms. Keil.

# **Privilege of the Floor:**

- -Brandon Himoff asked if the ends of the new fence at the beach would be damaged by the ice when the pond freezes. The consensus was it would not be a problem.
- -Rich Nawrot asked if the Town would beautify the new sign in Adirondack. He said if the town would provide materials and equipment he has volunteers that will do the work. Supervisor Simpson said there is Occupancy Tax money available and Councilperson Smith will work on this.
