She explained variances are being requested for the following setbacks: septic tank to dwelling 5' proposed (10' required); septic tank to property line 4.2' proposed (10' required); distribution box to neighboring well 96.4' proposed (100' required); absorption field to property line 1.1' proposed (10' required); and absorption field to dwelling 2.5' proposed (20' required). Jim Steen said he feels this is the best plan to meet setbacks to neighboring wells. The Board deemed the application complete and set a public hearing.

WHEREAS, pursuant to General Municipal Law Section 216, the Horicon Town Board previously adopted a defined benefit Volunteer Firefighter Service Award Program (the "Program"), as described in General Municipal Law Section 219, which was effective January 12, 1999 and amended in 2006 and 2013; and

WHEREAS, investment of the Program's assets has resulted in sufficient funds to allow an increase in the benefit amount; and

WHEREAS, the Town Board wishes to amend portions of the Volunteer Fire Fighter Service Award Program Plan Document to increase the benefit amount; and

WHEREAS, such an amendment is authorized, subject to a mandatory referendum, pursuant to Article 11-A of the New York General Municipal Law; and

WHEREAS, the amendment is not expected to result in any increase in cost to property owners in the Town Fire Protection District; NOW, THEREFORE, BE IT

RESOLVED, that the Horicon Town Board hereby amends the Volunteer Firefighter Service Award Program to increase the benefit at age 65 from \$10 per month to \$15 per month, with a related increase in the maximum monthly benefit that may be earned from \$250 to \$375; and be it

FURTHER RESOLVED, that in order to effectuate the approved amendments, the Town Board adopts the following revisions to the Horicon Fire Department, Inc. Length of Service Award Program Plan Document dated December 2013 (the "Plan") and the Horicon Fire Department, Inc. Length of Service Award Program Summary of Program Provisions dated December 2013 (the "Summary"), subject to a mandatory referendum at the November 3, 2015 general/biennial election:

- 1. Section 11 of the Plan is amended as follows:
  - **11. Monthly Service Award**: As of January 1, 2016, \$15 per year of Service Credit up to the Maximum Years of Service Credit (see #14). For service prior to January 1, 2016, the Monthly Service Award is \$10 per year of Service Credit up to the Maximum Years of Service Credit.
- 2. Section 12 of the Plan is amended as follows:
  - **12. Accrued Monthly Service Award**: A Participant's Accrued Monthly Service Award equals a Participant's years of Service Credit times the Monthly Service Award and shall be paid after attainment of the Entitlement Age at the Participant's Benefit Commencement Date in accordance with provision #19 and provision #20 of this Plan Document. The Accrued Monthly

Service Award shall be adjusted for Service Credit earned after attainment of the Entitlement Age in accordance with provision #13e. As of January 1, 2016, the maximum Accrued Monthly Service Award is \$375. For service prior to January 1, 2016, the maximum Accrued Monthly Service Award is \$250.

3. The fifth bulleted paragraph on page 1 of the Summary, entitled "Accrued Monthly Service Award", is amended as follows:

Accrued Monthly Service Award: A participant's Accrued Monthly Service Award is equal to \$15 per year of Service Credit earned (including Prior Service Credit). The maximum Accrued Monthly Service Award that may be earned is \$375. The Accrued Monthly Service Award is paid to the Participant each month for life beginning on the first day of the month on or after turning age 65. A minimum of 120 payments are guaranteed to be made.

4. The third bulleted paragraph on page 2 of the Summary, entitled "Post Entitlement Age", is amended as follows:

Post-Entitlement Age: Effective January 1, 2015, Participants who remain active volunteer firefighters after age 65 and earn additional years of Service Credit will have their Accrued Monthly Service Award payment increased by \$15 effective the January 1ST following the year in which the additional Service Credit was earned. This includes Service Credit earned in the year the Participant turns age 65. The actual increase in payments will not take place until Penflex receives the certified points listing sometime after January 1ST, however the increase will be retroactive to January 1<sup>ST</sup>, and be it

FURTHER RESOLVED, that the estimated annual cost of the amended Service Award Program will continue to be the \$28,973.10 included in the 2015 Town Budget, the estimated annual administration cost will remain at \$5,000, the projected monthly award will be \$15 per year of service up to a maximum of \$375 per month and the estimated annual cost per covered participant will be approximately \$750; and be it

FURTHER RESOLVED, that the Service Award Program shall continue to be administered by the Town of Horicon; and be it
